WHAT IS BECDD?

Building the Engine of Community Development in Detroit (BECDD) is a citywide process to strengthen all of our neighborhoods by building a coordinated, equitable system for community development work in Detroit.

BECDD'S THEORY OF CHANGE

For all of Detroit's neighborhoods to have a future, strong community development organizations and neighborhood-based grass roots organizations are necessary, to facilitate - advocate - coordinate - intervene - with many partners - to build people and places in all of our neighborhoods. For this to be possible, we need a long-term, equitable, citywide community development system for Detroit.

WHAT IS BECDD'S VISION FOR OUR NEIGHBORHOODS?

All people in every neighborhood in the city of Detroit live, work, and engage in healthy, thriving, sustainable and inclusive communities.

BECDD: A BRIEF HISTORY



WHERE DO BECDD'S RESOURCES COME FROM?

People: Over 250 stakeholder organizations and many more individuals have participated since 2016 in shaping this vision for an equitable community development system for Detroit. They have done it voluntarily. They participate in workgroups, committees and task forces. They have visited other cities to learn. They come to Forums and Summits. They are grass roots block club leaders, CDO and Intermediary and CDFI executives, city and state officials, philanthropy officers and academic staff.



GENERATING VITAL DETROIT NEIGHBORHOODS:

Seven Elements of a
Community Development
System



System Governance – an aligned, coordinated, accountable system

System Capitalization – sustainable long-term public/private resources for all the system elements

Capacity Building + Certification – coordinated support leading to powerful, effective CDOs and GROs

Education and Career Pathways – an equitable leadership pipeline of Detroiters for the CD sector

Neighborhood Voice and Advocacy – powerful, connected multi-sector tables in every Council district

Data and Evaluation – actionable data to measure progress toward “neighborhood vitality”

City Engagement – engaged, supportive city government working as partners with CDOs and GROs



THE NEIGHBORHOOD VITALITY INDEX



GOALS:

- Define “neighborhood success”: social cohesion + equity as foundational building blocks
- Measure progress over time
- Use data to promote and drive collaboration

IMPLEMENTATION TEAM:

- Data Driven Detroit and JFM Consulting Group
 - w/ engagement of NVI Pilot Task Force

KEY POINTS:

- Five types of indicators: Community Capacity, Resident Opportunity, Neighborhood Conditions, Quality of Life and Equity Impact
- 3-phase pilot project funded and underway starting in SNF + Brightmoor neighborhoods
- Using quantitative and qualitative data
- CDOs as main users + collectors of primary data
- The Index: a tool to report on progress over time

THE CITY-CDO SINGLE FAMILY REHAB PARTNERSHIP PILOT



GOALS:

- Neighborhood stabilization
- Housing affordability: as low as 50% AMI purchase price
- Leverage the partners to build capacity of the CDOs
- Demonstrate a partnership between City & CD sector

IMPLEMENTATION TEAM:

- Detroit Housing Compact
 - w/ engagement of 8 “pilot” CDOs + DLBA + HRD

KEY POINTS:

- 5-year pilot to build capacity of 8 CDOs, renovate 70 DLBA homes and sell to local residents
- \$8 million in CDBG under discussion with City
- Cinnaire identified as bridge lender
- Peer learning/cohort model for capacity building
- Housing Compact now doing pre-development and set-up work for 2021 launch

CD CAPACITY BUILDING DELIVERY SYSTEM



GOALS:

- Capable and effective Community Development Organizations and Neighborhood-Based Grass Roots Organizations
- Coordination of the services for easy access by CDOs/GROs
- High-Quality support for client organizations
- Accountability between TA Providers and client organizations


IMPLEMENTATION TEAM:

- CDAD, Co-act, Enterprise Community Partners, MCR, MMA

KEY POINTS:

- Building from each partner's existing capacity/knowledge
- A one-stop system for CDOs and GROs to obtain TA, especially in the specialty "community development" functions
- A framework that accommodates CD technical assistance initiatives already in play
- Monitoring to assure high-quality and relevant TA
- Roles, Workflow and budgets now being finalized

THE NEIGHBORHOOD VOICE AND ADVOCACY FRAMEWORK



GOALS:

- Increase neighborhood cohesion + build power
- Build relationships between people and institutions
- Build relationships across neighborhoods
- Increase resident/neighborhood voice in policy

IMPLEMENTATION TEAM:

- CDAD

KEY POINTS:

- Neighborhood-based social networks using “Connected Communities” model
- Centering those most impacted by decisions Collective decision-making and policy priorities
- Neighborhood innovation + problem solving
- Citywide “neighborhoods agenda”
- Pilot completed, hoped-for expansion in 2021

THE CD LEADERSHIP PIPELINE



GOALS:

- A Community Development Career Pathway: middle school age youth thru elder resident leaders
- A CD Career Portal to store and access CD career info

IMPLEMENTATION TEAM:

- 4 CDOs: CRCAA, ECN, C of C, UNI
 - w/ the "Youth in Community Development Consortium"

KEY POINTS:

- Consortium includes DESC, Higher-Ed, DPSCD
- CDO "Competency Framework" completed
- Three CD Certificate Tracks set to launch at WSU + LTU w/ more possible
- CD Curriculum for Middle and High School complete
- More partnerships now in development w/ DPSCD, DESC, UM Dearborn, WSU, Americorp, others
- First pilot partnership projected for late 2021

SYSTEM CAPITALIZATION TASK FORCE



GOAL:

- Sustainable, long-term public/private resources for a community development system

IMPLEMENTATION TEAM:

- BECDD System Capitalization Task Force with BECDD Steering Committee

KEY POINTS:

- Eleven Recommendations and Workplan finalized
- Task Force has pivoted to implementation mode
- Research on 2019-2020 CD capital-in-play being updated
- Task Force has catalyzed regular City-CDO conversations and “Funders Community Development Discussion Group”
- Task Force will sponsor “Alignment Forums” in 2021
- State Legislation - The “*MI Community Investment Program*” to *incentivize direct private donations to CDOs* – expects affirmative House Committee vote today!
- Ten-year plan for system sustainability by December 2021

SYSTEM GOVERNANCE: a collaborative, multi-stakeholder oversight and accountability structure



GOALS:

- An aligned, collaborative Detroit CD system
- Community development support in every City Council District

IMPLEMENTATION TEAM:

- The BECDD Steering Committee and CDAD

KEY POINTS:

- Transition into CDAD (serving as “backbone”) during 2021
- MOU in formation between CDAD + BECDD Steering Committee
- CDAD preparing to serve as “backbone”
- Workplan w/ ST/LT goals and corresponding data system in formation
- “CDO Coverage” process underway to generate a “District Model” for CD support in each Council District, completion in 2021
